## **AGENDA**

- 1. Approval of CLOUD constitution and election of officers. Our last meeting on 16 August agreed that CLOUD should have a written constitution in order to enhance our standing and give extra weight to our campaign. We will invite the meeting to:

At the 16 August meeting we agreed to set up an expert working group to investigate the Council's forecast of housing demand (which determines the 'need' for Bailrigg garden village) and the associated increase in traffic pollution and congestion. This group has now started work and will report progress.
